All that piece, parcel and lot of land situate in the state of South Carolina and County of Greenville as shown on the plat of Judson Mills and known as the Anderson Road property, and being designated on plat as lots No. 1 and 21. Boundaries and dimensions of said lots are as follows:
Lot #1 has a frontage on the Anderson Road of 65'-0" runs in a northwesterly direction along the Southern Public Utilities Co. track 1137'-0" to their spur track; thence in a southeasterly direction along the line of the Southern Public Utilities Co. spur track 1000'-0" to the Anderson Road, and containing 3.8 acres, more or less.
