Brown Street, in block between Washington and Caffee  
Streets, and having according to plan made by R. E. Tolton  
Engineer, September, 1923, the following water and bounds  
to - west: Beginning at a point on the western side  
of 13th east Street, which point is 60 feet 4 1/2 inches  
back of the southwest corner of Caffee and Brown  
Street, and in the southeast corner of a brick wall,  
and running thence along the southern side of said  
brick wall 26' 7 1/2 feet 5 1/2 inches to a point
