(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release unto the
said
J. D. Parish and P. C. Flower, all that certain lot or
parcell of land situate, lying and being in the City
of Greenville, County and State aforesaid, on the east
side of North Main Street in the block between Coffee
and Washington Streets, and having according to a plan
made by R. E. Dalton, Engineer, September, 1923, the follow-
ing lines and boundaries to wit: Beginning at a point
on the east side of North Main Street, 60 ft. 5 1/2 in.
South of the northeast corner of Main and Coffee Streets
which point is the corner of property now owned by
J. D. Parish and P. C. Flower; thence N. 70° 23' E.
140 feet to a point in a wall; thence S. 20° 20' E. 38 ft. 10
in. to an iron fence in an alley; thence with the northern
side of said alley N. 70° 20' W. 44 ft. to an iron fence; thence
N. 20° 56' E. 6 ft. 5 in. to an iron fence; thence N. 70° 50' W. 96
feet (about 63 feet of this distance runs along the
center of a wall) to a point on the east side of
North Main Street, which point is in the center of a
brick wall and is 93 feet 10 1/2 in. South of the south
east corner of Main and Coffee Streets, thence along
the western side of North Main Street N. 20° E. 33 feet
3 in. to the point of beginning.

Also a strip of land lying between the above
property and my lot which fronts about 38 ft. on
Brown Street, which strip of land is to be used as
an alley exclusively for the benefit of the land
herein bargained and my Brown Street lot, said land
described as follows: Beginning at a point on the
northern side of an alley, which point is 77 ft. west
from Brown Street and running thence N. 20° E. 38 ft. 9
in. to an iron fence at the back side of a wall; thence
N. 70° 23' W. 8 ft. 5 in. to a point in a wall; thence
N. 20° 20' E. 38 ft. 10 in. to an iron fence on the northern
side of an alley thence N. 70° 20' E. 8 ft. 5 in. to the
point of beginning.

It is understood that a portion of the land to
be used for the alley is now occupied by part of a
building. The tract is to receive such portion of
buildings when the lease thereon shall expire.
