at and before the sealing of these presents by Moncta A. Allison

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Moncta A. Allison, All that certain piece, parcel or lot of land situate and being in the City of Greenville, County and State aforesaid on what is known as Crescent Avenue, and having the following lines and courses:

Beginning at an iron pipe on the North side of Crescent Avenue three hundred and Sixty-five (365) feet from the Northeast corner of Crescent Avenue and Jones Avenue and at corner of Lot numbered four (4) in division of property of J. A. McDaniel thence along line of lot numbered four (4) N. 1-00 E. Two hundred (200) feet to an iron pipe on rear line; thence along rear line along property of grantor N. 84-37 E. 80 feet to an iron pipe corner of Lot numbered six (6); thence along line of lot numbered six (6) S. 1-00 W. two hundred (200) feet to an iron pipe on the North side of Crescent Avenue; thence along the North side of Crescent Avenue S. 84-37 W. Eighty (80) feet to the point of beginning, being known as Lot numbered five (5) on plat of property of J. A. McDaniel and being a portion of the above property devised to me by J. A. McDaniel.

Nevertheless, upon the following conditions, however, which conditions are a part of the consideration for this deed and are expressly for the benefit of all owners of the lots and shares on plat of said property:

(1) No building shall be erected nearer to the abutting sidewalk than fifty (50) feet.

(2) The facing of the lots as shown on said plat shall be strictly adhered to, however, more than one lot may be used for the purpose of erecting a dwelling.

(3) No building to be used as a dwelling shall be erected on the front of said lot other than a two story dwelling house costing at least Six Thousand Dollars (\$6000.00).

(4) The property conveyed shall never be sold or rented as otherwise disposed of to any person or persons of African descent.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Moncta A. Allison,
her heirs and assigns, forever.

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Moncta A. Allison,
her heirs and assigns, against

me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
