in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Mattie A. Roark, her heirs and assigns forever

all that piece, parcel or lot of land in Greenville Township, Greenville County State of South Carolina.

In the City of Greenville, in the Fifth (5th) Ward of said City on Arlington Avenue, and having the following meters and bounds, to-wit:  
Beginning at a stake on the South side of Arlington Avenue, (formerly known as Gailington Street), 157 feet eastward from the Southwest corner of Arlington Avenue and Menninger Street and running thence along the East Arlington Avenue 71.73-45 21.50 feet to a stake on corner of Lot No. 4; thence along of last mentioned lot 21.16-15 21.175 feet to a stake on a fifteen (15) foot alley; thence along said alley 27 1/2-45 21.50 feet to a stake on line of Lot No. 8; thence 71.18-15 21.175 feet along line of Lots nos 8 and 7 and 6 to the Beginning Corner and being the same lot conveyed to Lillian A. heirs and assigns, against us and our heirs, and every other person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
