Beginning at an iron pin on St. John Street at a point 218.8 feet from the intersection of St. Johns Street and Green Avenue, and running thence S 11 1/2 E 239.8 feet along line of lot owned to J. C. Holcombe (part lot no 3) to an iron pin on 12 foot alley; thence with said alley N 79 1/2 E 57.4 feet to an iron pin; thence N 11 1/2 E 239.8 feet to an iron pin on St. Johns Street; thence with said St. Johns Street S 79 E 57.4 feet to the point of beginning, being part of lot 3 and 4 as shown on plat of the property of Frank Hammond, recorded in the R.M.C.
