to the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Congregational Beth Israel

all that piece, parcel or lot of land in Greenville Township, Greenville County State of South Carolina, on Townes Street in the City of Greenville, having the following metes and bounds: Beginning at an iron pin on Townes Street, at joint corner with lot with ten foot frontage conveyed to Green by Louise B. Thomas on June 9, 1925, and lot herein conveyed, and running thence with said street 50 feet to iron pin; thence N. 72-15 W. 146 feet to iron pin, corner lots 2 and 3; thence S. 12 W. 48 feet to iron pin; thence S. 71-15 E. 143 feet to the beginning corner, being a portion of lot No. 2 as shown on plat recorded in plat book E, page 255, R. M. C. Office for Greenville County.
