The parceling described or lot of land known as lot 10 made up to W. E. Johnson, W. E. Jones, Greenville Co., on March 30th 1923 and recorded in Title Office, in the County of Greenville, Book No. 1, at page 108, 1st grantee, in the intersections of Grace Street and Marion Street and running thereof with Marion Road 50' x 10' feet, thence N. 54° E. 108' feet to the beginning corner.
