J. A. Gaskins, all that certain tract of land in the
Greenville Township, Greenville County, State of
South Carolina, near the City of Greenville, known
and designated as lot 110, block 12, section known
as Circle Circle and known as a plat agreed
in the R. M. B. Office for said County and State in
plat book #1, page 28, and having according to
said plat book containing metes and bounds, to wit:
Beginning at an iron pine on the eastern side
of Taxis Road, joint corner of late Nos. 96 and 97
and running thence with the joint line of said
late #11-556 1695 feet to an iron pine the joint
corner of late Nos. 96 and 97 and 98 and 99; thence
with the joint line of late Nos. 97 and 96 10.21-56
feet to another pine, then joint corner of late
Nos. 97, 98, 99 and 96; thence with the joint line
of late Nos. 95 and 96, N. 11-36 W. 174 feet to an iron
pine on the Taxis Road; thence with the eastern
side of Taxis Road 16-50 N. 49. 96 feet to the
