Know all men by these presents that I, Levi Bowers of the County of Greenville and State of South Carolina for an in consideration of the sum of one hundred and fifty dollars to me in hand paid by Daniel Bellum of the same state and County above said the receipt whereof I do hereby acknowledge have granted bargained sold and conveyed and by these presents do grant bargain sell and convey unto the Daniel Bellum, his heirs and assigns a certain tract of land on Water of South Carolina River, containing eighty acres more or less,

Beginning on a maple near the road leading from Mountains Hill Church thence down the Branch nearly north to the mouth of the branch at the creek thence with Joshua Pruitts line till it strikes Joshua Essell line thence with said line to a Hickory thence to a pine thence to a persimmon thence down the old line to sourwood corner thence to a stake thence to the beginning corner together with all and singular the rights, liberties, tenements and appurtenances thereto and I do hereby bind myself my heirs and assigns to warrant and forever defend the above mentioned premises unto the said Daniel Bellum, his heirs and assigns against myself my heirs and assigns and against every other person or persons lawfully claiming or to claim the same or any part thereof in witness whereof I have hereunto signed my name and affixed my seal this 20th day of October 1879, signed sealed and delivered in the presence of
