The grantor reserves to itself and its successors the right to authorise the plantage. maintaining, repairing and replacing of gas, water and sewer pipes, telephone, light and power lines, and any other instrument of public utility over or under any street, alley, park or lot at any time, without compensation to any lot owner; except that the premises shall be left in as good condition as before.
