To have and to hold all and singular the said Premises before mentioned unto the said Henry M. Cleveland, his Heirs and Assigns forever.

In it understood and agreed that, in case any part or all of the property hereby conveyed, either personal or real, is sold by the Executor of the B. M. Shuman, Estate, or whether sold through the Court, the grantee, Henry M. Cleveland, is to receive the interest in said property to which we, the undersigned, would have been entitled, and this instrument shall be full and complete authority for the said Henry M. Cleveland to receive and receipt the Executor of the said B. M. Shuman Estate or the officer of the Court through whom any of said property should be sold. We guarantee that the property hereby conveyed shall not be subject to any debts of our deceased mother, Morella Elizabeth Shuman Griner.
