(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

W. E. Rusch, all that certain piece parcel or lot of land in Greenville Township, Greenville County State of South Carolina known as Lot 7, known and designated as Lot 7 in Book 1 of the subdivision known as Augusta Court, as shown on a plat of land in the R. M. C. Office for Greenville County in Book 1 page 124, and having according to said plat the following metes and bounds to-wit:

Beginning at a pt. on the corner of Augusta Road and a new street running through this subdivision and running thence with said new street S 52-03 W 101 feet to a stake 50 feet from the corner of lot 7, thence along a curve to the right the cord of which is 75.7 feet to a stake in line of lot 7, 50 feet from the corner of the said new street, thence with line of lot 7 N 77-57 W 53.55 feet to a stake, corner of lot 5, thence with line of lot 5 N 72-53-17 E 229.2 feet to a stake on Augusta Road, thence with Augusta Road S 24-35 E 101.5 feet to the remaining corner and being the same lot of land conveyed to me, the said W. W. Lee by Judson W. Chapman, by his deed dated July 13th, 1925 not yet recorded.

Office for Greenville County in Vol 90 at page 262, the said loan being paid down to eight hundred seventy (\$870.00) dollars with interest paid through January 30th, 1926
