Beginning at an iron pin on the corner of Hillside Avenue and Hillside Avenue (formerly Smith Street) and Hillside Avenue, and running thence along side of Hillside Avenue in a southerly direction 50 feet, more or less, to an iron pin, thence in a westerly direction 121 feet more or less, to an iron pin, thence in a northerly direction 25 feet, more or less, to an iron pin on Hillside Avenue, thence along Hillside Avenue 121 feet, more or less, to the beginning corner, and being known and designated as lot Number 19 on the above named plat and being on the corner of said Avenue herein named, the deed is executed subject, however, to all the conditions and restrictions as are shown in deed to A.
