the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Thamie C. Spearman, all that piece, parcel or lot of land, in Greenville Township, Greenville County, State of South Carolina, designated as Lot No. 11 in the subdivision of "Fosters" as shown by plat recorded in Plat Book of page 42, R. 7m. C. records for Greenville County, said lot having a frontage of 65 feet on Beechwood Avenue; a depth of 136.4 feet along lines of lot #10; a depth of 141.4 feet along the line of lot #12 and a width of 72 feet in the rear.

This Conveyance is made upon the following conditions which are part of the Consideration for this deed, and are hereby declared to be Conditions subsequent, to wit: (1) Said property is to be used only for residential purposes and no building shall be erected thereon, costing less than \$2,000 or bears less than 25 feet to the inside line of the sidewalk fronting said property. (2) This property shall not be sold, leased or in any manner disposed of to persons of African descent.

As part of the Consideration for this conveyance the grantee assumes and agrees to pay the principal and accrued interest on a note and mortgage of \$100.00 in favor of P. G. Tillman, which note and mortgage have been duly assigned to the American Building and Loan Association, also a note and mortgage in favor of the American Building and Loan Association in amount of \$2,500.00, reference to the record of said mortgages being made for terms and conditions, thereof.

The above land is the same conveyed to me by G. B. Lee by deed dated the seventeenth day of October, nineteen hundred twenty-four and recorded in volume 91, page 567, of Deeds in the office of the Register of Deed Conveyance for Greenville County.

The above described land is the same conveyed to me by W. H. Spearman, Sr. on the 15th day of September, 1926, deed recorded in office of Register of Deed Conveyance for Greenville County, in Book 192, Page 192.

TO HAVE AND TO HOLD, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
