The purchaser agrees to pay all taxes while this contract is in force.

It is agreed that time is of the essence of this contract, and if the said payments are not made when due, I shall be discharged in law and equity from all liability to make said deed, and may treat said J. A. James.

as tenant holding over after termination, or contrary to the terms of this lease, and shall be entitled to claim and recover, or retain if already paid.

the sum of One hundred eighty and 00/100 Dollars, per year for rent, or by way of liquidated damages, or may enforce payment of said note.

have agreed to sell to

It is understood and agreed that said lot is covered by a mortgage of \$1800 to the American Building & Loan Association. At 100 the purchaser shall have paid \$500 on the purchase price of said lot.
