Rush, all that lot piece or parcel of land in Greenville Township, Greenville County S.C. having 4 1/2 acre Road no. north Cherokee Park year 1901 incorporated limits of the city of Greenville, being lot No. 9 of subdivision of Cherokee Park made by W. E. Rush October 1909 and recorded in plat book "C" in file of offices of R. M. C. for said County said lot having a parallelogram of 64 feet on the east side of Road with a depth of 17 1/2 feet the parallel lines being the same lot of land transferred to the Grantee by W. E. Rush by his deed dated January 19th 1926 not yet recorded.

It is a part of the consideration for this instrument that the Grantee assumes and agrees to pay a certain mortgage covering the aforesaid described lot heretofore executed by W. E. Rush to R. M.
