 the sum of One thousand two hundred and twenty five dollars,  
 and other valuable considerations,

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee..... hereinafter named (the receipt whereof is hereby acknowledged)  
 has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Alma L. Nickle

all of that certain piece, parcel or lot of land  
 situate, lying and being in Greenville Township,  
 Greenville County, State of South Carolina,  
 lying on the west side of Hillside Drive or Circle  
 A street in Hillside Heights Sub division, a plat of which  
 is recorded in Book 1, page 1, sold by said corporation  
 in Plat Book 3, page 1, sold lot having the  
 following metes and bounds to wit: Beginning  
 at a point on the West side of said Circle Street  
 or Hillside Drive 90 feet in a southerly direction  
 from a point where said street intersects over  
 brook street car line, and running thence N.  
 18° 45' W. along the western line of said street 35  
 feet to a stake, thence N. 75° 57' W. 5 feet to a  
 stake in line of lot owned by the grantee;  
 thence with said line N. 78° 15' E. 44 feet to the  
 beginning corner on said street, the same being  
 the triangular strip on the front conveyed  
 off of the lot of land acquired by the grantee  
 from C. Brown Master by his deed dated  
 May 6, 1927, recorded in R.M.C. Office for Greenville  
 County in Deed Book 139, page 24, the grantee  
 on this date is conveying to the grantee a  
 triangular strip to the rear in exchange  
 for the above strip.

 TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee..... hereinabove named, and her  
 heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee.....  
 hereinabove named, and her  
 heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

 officers on this the 8th day of September, 1927, in the year of our Lord one thousand nine  
 hundred and twenty seven and in the one hundred and forty second year of the
