KNOW ALL MEN BY THESE PRESENTS. That Kenesaw Investment Corporation,

a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville, in the State of South Carolina, for and in consideration of the sum of Ten Dollars and the assumption of mortgage indebtedness in the sum of \$6886.67 DOLLARS

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee, hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released and by these presents does grant, bargain, sell and release unto

Parcel one: All that piece, parcel or lot of land situate, lying and being in Greenville County, State aforesaid, about three miles from Greenville Court House, and known and designated as the Western portion of Lots Nos. 12 and 13, plat of R. E. Dalton, C.E., August, 1922, described as follows: Beginning at an iron pin on the Mcbee Spring Road 503.2 feet from Augusta Road, and running thence S. 66-12 W. 60 feet along Mcbee Spring Road to an iron pin, corner of said road and a forty-foot street; thence with 40 foot street S. 26-31 E. 193.4 feet to an iron pin, corner of Lot No. 14; thence with line of Lot No. 14, N. 62-27 E. 60 feet to a pin in line of lot now or formerly of Mrs. Simpson thence N. 26-31 E. 193 feet, more or less, to the beginning corner, and being the same lot conveyed to W. Parcel Two. All that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, near the City of Greenville in what is known as the "Morgan Hill Addition", said lot having a frontage on Morgan Street of Sixty (60) and a depth of Two Hundred (200) feet, and being known as Lot No. 32, of the Morgan Hill Addition, and being the same land conveyed to W. D. Workman by R. J. Rowley by deed dated Jan. 31, 1924, recorded in R. M.C. Office for Greenville County in Vol. 92, page 293.

Parcel Three: All those certain lots or parcels of land situate, lying and being on Falls and Cauble Sts., in the City of Greenville, County and State aforesaid, known and designated as Lots Nos. 8 and 9 on Cauble St., and Lot no. 20 and the southern half of Lot No. 19 on Falls St., according to a plat of the property of Charles French Tom, Jr., made by R. Office for Greenville County in Plat Book "F", page 222, and having the following metes and bounds, to-wit: Lots 8 and 9, Beginning at an iron pin on the south side of Cauble St., joint corner of Lots 7 and 8, and running thence with joint line of said lots S. 20-25 E. 101.4 feet to an iron pin; thence S. 70-30 E. 40 feet to an iron pin in line with Lot No. 10; thence with line of Lot No. 10, N. 19-20 E. 101.9 feet to an iron pin on Cauble St; thence with said Cauble St. N. 71-05 E. 382 feet to the beginning corner.
