Beginning at a stake on the eastern line of Balsam Road at the corner common to lots thirty-seven (37) and thirty-eight (38) as shown on said plat, and running thence along the dividing line between said lots thirty-seven (37) and thirty-eight (38) North 56 deg. 28 min. East two hundred ninety-eight and three tenths (298.3) feet to a stake on the southwest line of a certain alley; thence along the southwest line of said alley South 42 deg. 24 min.
