And the said Tryon Development Company, does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the heirs and assigns, against itself and its successors and all persons lawfully claiming, to claim the same, or any part thereof,

This conveyance is made subject to the following conditions, restrictions and covenants running with the land, for a violation of the first of which the title shall immediately revert to the grantor, his successors or assigns, except as against lien creditors, to-wit:

FIRST: That the property hereby conveyed, or any part thereof, is not to be sold, rented, leased or otherwise disposed of to any person of African descent, be taken to prevent the grantor herein from designating certain lots of this development or any future addition thereto for business purposes or for other purposes desirable in the opinion of grantor, in promoting said development, the right to do so being hereby expressly reserved by grantor.

THIRD: That no use shall be made of any lot which, in the opinion of the grantor herein, will constitute a nuisance, or prove in any way noxious or offensive to the neighboring inhabitants, or injure the value of neighboring lots.

FOURTH: That no dwelling house shall be built on the above described lot to cost less than *Three Thousand Dollars*.

residence, garage, or other building whatsoever, shall be erected on said lot until, and unless, the plans and specifications thereof have been submitted to and approved be, as shown and indicated on the plat hereinabove, and the buildings on said land shall be erected on or within the building line, or the house location, as the case may shall face or front on the street or road on which the lot herewith conveyed is to, and in strict accord with the plans and specifications so required to be submitted and approved, and

FIFTH: That not more than one residence shall be erected on or within the building line and not nearer than five feet to any side or back line of any adjoining residence, there may be erected a garage and servant's quarters, (the plans for which are to be first approved as hereinabove provided) in keeping with the premises, and residence, and residence built thereon, of slightly appearance and appropriate location, within the building line and not nearer than five feet to any side or back line of any adjoining

SIXTH: That the parties interested, heirs and assigns, will not, during the term of twenty-one years from April 1, 1925, subdivide, sell or convey any part or parcel of said lots, less than the whole of which heretofore, as shown on said plat (the grantor hereby reserving the right, however, to sell and con-

on said plat, and the further right to determine the size and shape of lots sold for other than residential purposes.)

SEVENTH: That the grantor herein reserves the right to lay, erect and maintain, or cause to be laid, the laying, erecting and maintaining of sewer, gas, and water pipes, electric conductors or pipes, telegraph, telephone and electric light poles, and any other such public utility, on or in any of the roadways, streets or alleys bordering said property, without compensation to the same along the back and side lines of the lot above described, and to grade surface, and repair the said roadways,

EIGHTH: That no surface closet or other uninclosed device for the disposal of sewage shall ever be installed or maintained on the lot herewith conveyed, grantor herein agreeing that upon the written request of the owner of the lot made at any time within three years after the date of execution of this deed, grantor will install on said lot a septic tank, or other sanitary device for disposal of sewage, and owner shall have the right to connect to and use the same; PROVIDED, HOWEVER, that in such event, grantor is to have the right, without reimbursement to the owner of said lot, to connect to said septic tank or other sanitary device one or more owners of other lots, or grant them the right to so connect, according to the capacity of said septic tank or other sanitary device.
