do hereby certify that the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Bright R. McKee, all that certain piece, parcel or lot of land situated, lying and being in the City of Greenville, South Carolina, State of South Carolina, on the South side of Barclay Street, being more fully designated as lot, no. 8-4, as shown on plat of Barclay Street, recorded in Plat Book 13 at page 230, and having according to a plat thereof prepared by William F. Ingalls, May 1927, the following meter and bounds, to-wit: Beginning at an iron pipe on the north side of Barclay Street and running thence along the line of lot no. 8-4 to an iron pipe in line of lot no. 8-5; thence across the line of lot no. 8-4 to an iron pipe on the north side of Barclay Street; thence with the north side of Barclay Street to the point of beginning.

It is understood that the sewer later in front of the property is for the benefit of this lot and lot no. 8-5 on the west side referred to.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Bright R. McKee

her and assigns, forever, subject, however to the following restrictions which are for the benefit of all persons owning lots as shown on said plat: (1) The property shall never be sold, rented or otherwise disposed of to persons having any percentage of negro blood. (2) no building shall be erected on said lot nearer to Barclay than thirty feet, and only one dwelling shall be erected on said lot, except one servant house may be placed on the rear end of said lot. (3) The property shall be used exclusively for white residential purposes and no filling station, store or apartment house shall ever be placed on said premises.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Bright R. McKee

myself and my heirs, and against every person whomsoever lawfully claiming, or to claim the same, or any part thereof.
