*with that certain piece of parcel of land situated bying and being in the State of South Carolina, County of Greenville, on the North side of the main street, and being known and designated as "No. 29, A. which March Hill" property, according to a plat hereof made by S. L. and T. H. Engineers, dated 1887, and recorded in the books of the County of Greenville, at 11:00 A. M. of 1887, and having the following metes and bounds:*  
*Beginning at a corner in Fairview Street 17 feet from the southeast corner of Fairview and 117 feet from the street, and running thence with the main street 70.5 feet to a point more or less to a point in the eastern line of lot 2 and at the southern end of a 10 foot alley, thence with the southern end of said alley, and with the southern line of lot No. 29, 57.5 feet, more or less, to an iron pipe corner of lot No. 29, said pipe being 17 feet from the western side of No. 29 street, thence with the line of lot No. 29, 19 feet, 9.5 feet to the beginning corner.*
