(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J. Shaw Faulk for the term of his natural
life:
All that piece, parcel or tract of land, lying,
being and situate in the County and State
aforesaid and on the West side of the Green-
ville & Laurens Public Road & C. & N. C. Railroad, west
are small portions lying between the C. & N. C. Rail-
road and the Greenville & Laurens Public Road
with the following metes and bounds,
to-wit:

Beginning at a stone in the Greenville
& Laurens Public Highway, near H. M. Buchanan,
running thence across C. & N. C. Railroad & 49.50 ft.
50.86 to stone, thence S 43.25 W. 11.12 to stone,
thence N 58.31 E. 3.00 to iron pin, thence N 41.75 E.
21.70 to iron pin, thence N 26.50 W. 14.47 to iron
pin in road leading from Bucklehorn Church
to J. D. Richardson's, thence up said road
to a point near the C. & N. C. Railroad; thence
S 55.06 E. 16.67 to stone, thence S 56.25 E. across
Railroad 11.75 to the beginning corner,
containing corner and containing forty-
three and thirty-seven one hundredths
43.37 acres, more or less as shown by a plat
made by G. C. Carey, Surveyor, dated November 12,
