for the sum of *Three hundred (\$300.00)* Dollars, being at that price the highest bidder therefor.

NOW, therefore, Know all Men by these Presents, That *E. E. Egan* Master in and for the County of Greenville, aforesaid, in consideration of the sum of *Three hundred (\$300.00)* Dollars, to me paid by the said *R. E. Johnson*

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

R. E. Johnson and his heirs and assigns forever, the following described real estate, to wit: all that lot of land in said State and County, more particularly described as follows, to wit: Beginning at and from the corner of said street N. 17-45 E. 55 feet to the corner of Lot #7; thence along the line of said Lot #7, 150 feet to the line of Lot #8; thence along the line of Lot #8, 150 feet to the beginning corner, and being designated as Lot #7 on a plat of the R. E. Johnson property made by A. S. Brockman, Surveyor, February 23, 1924.

Also, that other lot of land adjoining the above described lot and having the following meter and bounds, to wit: Beginning on an unnamed street at the corner of Lot #7 and runs thence with said street N. 17-45 E. 55 feet to the corner of Lot #5; thence along the line of Lot #5, 150 feet to the line of Lot #8; thence along the line of Lot #8, 150 feet to the corner of Lot #7; thence along the line of Lot #7, 150 feet to the beginning corner, and being designated as Lot #6 on said plat.
