The Railroad Commission of South Carolina Columbia.

Application for the Sale or Transfer of Certificate of Public Convenience and Necessity.
To the Railroad Commission of South Carolina, Columbia, S. C., June x 1931.

I, Mrs. Emalie K. Hayes, the holder of Class A, Certificate of Public Convenience and Necessity No. 6, which authorizes bus service between Greenville, S. C. and Columbia, S. C. via Laurens and Newberry., the proposed purchaser or transferee, respectfully request that authority be granted said holder of Class A, Certificate No. 6, to sell or transfer all my rights, title and interest under said Certificate to the purchaser or transferee, and for the purpose of enabling the Commission to determine whether or not this application should be granted the following information is submitted.

The purchaser or transferee submits herewith a Exhibit 3, application for Class A, Certificate of Public Convenience and Necessity to conduct the operation as heretofore conducted as set forth above and submits as Exhibit 3 (a) copy of proposed tariff, which is the same as is now in effect except ; submits a Exhibit 3 (b) proposed time schedule, which is the same as now in effect except ; submits a Exhibit 3 (c) proposed route and mileage, which is the same as is now in effect except ; and submits as Exhibit 3(d) proposed list of equipment to be used.

4. The Certificate to be transferred is submitted herewith as Exhibit 4.

5. Are there now any liens, mortgages, or hypothecations in effect over, against, or in any way affecting this Certificate? Yes. If so, give as Exhibit 5 a complete list, showing dates, amounts, and names and addresses of parties in whose favor drawn.

6. Is the proposed sale or transfer being made in any way for the purpose of hindering delaying or defrauding creditors? No.
