NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS, That, for and in considerate in ef the sum of One (\$1.00) Dellar and the premises, the Realty Corporation, The Norwood National Bank, as Trustee, The South Carolina National Bank, successor of The Norwood National Bank, hereby declare that the terms of trust upon which lots #162, 294, 295 and 297 of Traxler Park, were conveyed by the Realty Corporation to The Norwood National Bank, as Trustee (but which terms were inadvertently emitted from said deed, which is recorded in said effice in Deeds Vol. 116, at page 126) were the same terms of trust as are fully set cut in the deed by the Realty Corporation to The Norwood National Bank, as Trustee, recorded in said effice in Deeds Vol. 116 at page 12, which said terms are as follows, to-wit;

"Upon the following trusts nevertheless, to sell and convey the said lands, either as a whole or in such parcels as it may deem advisable in accordance with an agreement between Realty Corporation and The Norwood National Bank of Greenville, South Carolina, the purchaser or purchasers of said property are not bound to see to the application of the purchase money or any part thereof, but shall take their let free and discharged of all trusts."
