(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Edna Mae Hunter, All that piece, parcel or tract of land situate, lying and being in Austin Township, County and State aforesaid and being known and designated as tract No. 2 on plat of Nannie H. White property made by W. J. Riddle date March 1936 and more fully described as follows:

Beginning at an iron pin in the public road at A. J. Smith, corner and running thence along line of A. J. Smith land S. 43-45 E. 1960 feet to stake at the branch; thence along said branch at the line S. 81-30 E. 165 feet to bend in branch; then N. 35-15 W. 174 feet to a bend, then N. 50 E. 452 feet to a stake at corner of lot No. 1; thence along line of lot No. 1, N. 80-45 W. 560 feet to a stake; thence N. 35-30 W. 1850 feet to an iron pin in the road; thence along said road S. 39 W. 117.5 feet to an iron pin; thence further along said road S. 33-30 W. 575.5 feet to the beginning corner, and containing 26.40 Acres, more or less.
