All that certain lot or parcel of land situate, lying and being in the Town of Fountain Inn on the East side of Main Street, and known and designated as lot No. 2 of the property of R. B. Holladay, divided and deeded to his children, said land having a frontage of 33 1/2 feet on Main Street and running back 59 feet in a parallell line to an alley bounded on the south by lot No. 1, on the North by lot No. 3 of the aforesaid subdivision and being the same as heretofore conveyed to H. W. Wilbourn by C. C. Good, Esq., dated June 2, 1925 which deed is recorded in the office of R. H. C. for Greenville, received by the Peoples Bank of Fountain Inn, 108, at page 12, and recorded in the Deed Book 108, at page 197.
