to it in hand duly paid at and before the sealing and delivery of these presents by the grantee..... hereinafter named (the receipt whereof is hereby acknowledged),

has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto B. P. O'Neal

all that piece, parcel or lot of land situate, lying and being in the Township of Greenville, County of Greenville, State of South Carolina, about one mile South of the Corporate limits of the City of Greenville, being known and designated as lot No 292 on a subdivision plat known as Greer Park, which plat is recorded in the office of the St. J. E. + C. Greenville County, Plat Book 3, page 114 and running according to said plat the following Yards bounds: Corner said distances; Plat made by R. E. Dalton to E. G. Hall March 1923.

Beginning at an iron pin on the North side of Rock Creek Drive, joint corner of lots 292 and 293, and running thence with said joint line North 25-25 West 250 feet to a stake, thence North 62-34 East 70 feet to a stake and South the joint line of lots 292 and 291 South 25-25 East 27-3-6 feet to an iron pin on the North side of Rock Creek Drive; thence with said drive as the line South 59-17 West 70-3 feet to the beginning corner. The grantor agrees that for the above consideration he will be required to place free of all cost side walks and gutter curbing in front of the above lot # 292.

This property or any part thereof, shall never be sold, rented or otherwise disposed of to any person bearing any brand or name, 2. No liquor or spurious, 3. The property shall be used only for residential purposes and no use shall be made thereof which would contribute a nuisance or increase the value of neighboring lots. 4. No dwelling house costing less than \$3500.00 shall be erected on said property, nor shall any building be erected thereon to rock creek drive than sixty feet. 5. The grantor reserves the right to lay and place, or authorize the laying and placing of street car, blocks, sewer gutters, paving and piping, the erection of telephone, telegraph and electric light poles, or the placing of any other public utility in or along any of the roadways without liability to compensate any lot owner.

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee..... hereinabove named, and his

heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee..... hereinabove named, and

heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
