has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Carolina Loan & Trust Co.

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina in Ward Six of the City of Greenville;

Beginning at an iron pin, the N.W. corner of Lucille Ave. and Houston St., and running thence with Houston St. N. 2 E. 70.1 feet to an iron pin; thence S. 88 W. approximately 125 feet to an iron pin on line of lot no 12, as shown on Plat of 'Chapin's Springs Land Co., recorded in Plat Book "C" page 41; thence with line of lot no 12 in a southerly direction 70 feet to an iron pin on Lucille Ave., thence with Lucille Ave. N. 13 E. 120.2 feet to the beginning corner, being all of lot no 11 of Block "C" on said plat and a strip of 5 feet in width taken from the south side of lot no 10.

The above described land is the same conveyed to E. M. Mitchell by Julia D. Charles by deed recorded in Office of R. M. C. for Greenville County in Vol 134, page 557, and conveyed to Cherry Investment Co. by E. M. Mitchell by deed dated Dec 16, 1932, not yet recorded.

Also those three lots of land in the Township County and State aforesaid known and ^{designated} as lots Nos 6, 7 and 8 on plat of subdivision of Theron Earle's property known as Oaklawn, said plat recorded in Plat Book E, page 273, the said lots having a frontage on Butlerford Road of 75 feet and a depth of 125 feet, being a portion of the land conveyed to Cherry Investment Company by Julia D. Charles, by deed dated Oct 15, 1932, and recorded in R. M. C. for said County in Book 144 page 193.

This conveyance is made subject to all outstanding tax and paying liens.
