and to construct and maintain in, upon, and through said right of way premises, in a proper manner, with poles, towers, wires and other necessary apparatus and appliances, a  
line for the purpose of transmitting power of electricity, together with the right, at all times, to enter upon said premises for the purpose of inspecting said line  
and making necessary repairs and alterations thereon; together with the right to keep said right of way clear of all structures for the space of thirty-four feet  
(34) on each side of the center of said power line, with the further right to cut away and keep clear of said line and wires all trees or other like obstructions that  
might in any way endanger the proper operation of same.

This is understood and agreed that above easement shall  
constitute narrow strip on west side of Buscombe Road  
sufficiently wide to set over line of poles, not tower

hereby grant unto the said SOUTHERN POWER COMPANY, its successors and assigns, the right, privilege, and easement to go in and upon that tract of land  
situated in said County and State, bounded by lands of as follows: along the western

side of the Buscombe Road and only sufficiently wide  
to construct and maintain, through and preserve  
a cutting said road, which is between the property of  
B. F. Thackston on the one side and W. H. Thackston  
on the other, an electric line.

and to construct and maintain in, upon, and through said premises, in a proper manner, with poles, towers, wires and other necessary apparatus and appliances, a  
line for the purpose of transmitting power of electricity, together with the right, at all times, to enter upon said premises for the purpose of inspecting said line  
and making necessary repairs and alterations thereon; together with the right to keep said right of way clear of all structures for the space of thirty-four feet  
(34) on each side of the center of said power line, with the further right to cut away and keep clear of said line and wires all trees or other like obstructions that  
might in any way endanger the proper operation of same.

provided, however, no tree or limb shall be  
shall be cut or chopped without the consent of the grantee and that  
only under the supervision of them or their representatives. And provided  
that no power lines shall at any time carry any voltage in excess  
of that carried by lines running along residential streets in  
City of Greenville, S. C.
