TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *P. J. Vaughan*, his

heirs and assigns, forever.

to *one* in hand paid  
at and before the sealing of these presents by *P. J. Vaughan*.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said  
P. J. Vaughan his heirs and assigns, all those pieces certain pieces of parcels, tracts  
and lots of land situated, lying and being in Greenville County, Greenville  
County, S.C., as follows: Tract no. 1. Located in the town of Hert Greenville  
having been and designated as lot 10 on plat made by W. C. Peas, Engineer  
May 17, 1918 and having the following metes and bounds: Beginning  
at a tree on back roadway and adjoining lot no. 8, so designated on  
said plat and running thence N 19° 36' 79.5 feet to a peg; thence S. 71°  
50.7 feet to peg on paved roadway; thence S along said paved roadway  
11 feet to beginning corner, thence in the same lot conveyed to me by  
James McRae by deed dated April 5, 1922 and recorded in O. M. C. office  
for Greenville County, S.C. in volume 74 page 469.

Tract no. 2. Located near Pendleton Road and more particularly  
described as follows: Beginning at the Southwest intersection of Landal  
Street and a paved road corner of lot no. 12-a, and running thence N  
79-00 W. said Landal Street 125 feet to corner of lot no. 9; thence S. 15-20'  
and 12-6, 60' feet to corner of lot no. 11, thence with lines of lot no.  
11 S. 19-00 E. 14 feet 8 inches to joint corner lots 11 and 12-b on said  
paved road; thence with said paved road N. 55-20 E. 78 feet and 10 inches  
to the beginning corner and being designated as lot nos. 12-a, 12-b  
and 12-c on plat of property of Mary G. Prater, dated Aug. 1926 and  
being known as lot no. 2 on plat recorded in O. M. C. office for  
said county on plat Book "D" at page 27 and being the same  
property conveyed to me by Mary G. Prater by deed dated Dec. 23,  
1926 recorded in O. M. C. office for Greenville Co. S.C. in vol. 119 page 260.

Tract no. 3. Located in the town of Hert Greenville and described as follows:  
all that lot, piece or parcel of land having the following metes and bounds,  
according to a plat of land known as Brandon Homes which plat is recorded  
in plat book 6, page 218, town: Beginning at a stake on corner of a 20 foot street  
and Pendleton Road and running thence along Pendleton Road 50 feet to a stake  
corner of lot no. 7, thence along line of lot 7, 4 feet 20-23-30 E. 13-0 feet to a stake on  
line of lot 9, thence along line of lot 9, N. 71-7 W. 39-6 feet to a stake on 20 foot street  
join corner lots 8 and 9; thence along said 20 foot street E. 22-30 W. 13-0-3 feet  
to the beginning corner and being known and designated as lot #8 on the above named plat.

Tract no. 4. Located in the town of Hert Greenville and having the following metes and  
bounds: Beginning at stake on a 20 foot street corner of lot 8 and running thence  
along lines of lots 7 and 8 back 71-6-68-8 feet to a stake on line of lot 7,  
corner of lot 10, thence along line of lot 10, 125 feet to a stake on Landal  
Street, thence along Landal Street 7-17-7-47 feet to a stake on a 20 foot street  
thence along 20 foot street in a Southwest direction 12-1-7 feet to the beginning  
corner and being known and designated as lot #9 on plat of land known as  
Brandon Homes, which plat is recorded in plat book 6 at page 218 and being  
the same lot of land conveyed to me by P. J. Rawley, deed dated November  
15, 1921 and recorded in volume 73 at page 293.

Tract no. 5. Located about two (2) miles west of the city of Greenville and  
having the following metes and bounds as shown on plat made by W. C. Peas on May 17,  
1918 and being lot no. 11 on said plat and lying north of paved roadway, beginning at  
corner of lot no. 10 now or formerly owned by E. E. Johnson and running N 71° 21' feet 5 inches  
to a point at corner of lot 9, corner of lot 9, 68-8 feet to a corner, thence S. 78° E. 75 feet 3 inches along lot no. 12 to corner  
of lot 13, 68 feet long said lot 9 to a corner, thence S. 78° E. 75 feet 3 inches along said paved roadway to beginning corner, being the same  
tract of land conveyed to me by W. E. Smith, Vol. 17, page 250 and recorded in O. M. C. office for Greenville County, S.C. in vol. 73 page 294.
