the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

Lillie (Dus) Bams, and her heirs and assigns forever, the following, described, real estate: All that piece or parcel or tract of land situate, lying and being in the State and County aforesaid, part of Pop Creek, waters of South Sugar River, with the following metes and bounds: Beginning at a stake in center of Pop Creek. Post Prince corner, thence S. 110. E. 37.89 ch. to a stone; thence N. 67. 1/2 W. 11.00 ch. to a stone; thence S. 19. W. 37.50 to Pop Creek; thence down and with the meanderings of the said creek to the beginning corner, containing 4.1 acres, more or less, adjoining lands of David Cannon, Let Price and others.
