Augusta Road School site, South Carolina, near the

C. S. Martin Subdivision, as shown on a plat of land

said plat, the following metes and bounds, to-wit:
Beginning at an iron pipe on Highland Drive, point
corner of Lots Nos. 27 and 28 and running thence
N. 48-50th. 180 feet; thence S. 41-106. 71 feet; thence S.
48-50th. 180 feet; thence with Highland Drive N. 41-102th.
