November 9th, 1891, and recorded in Office of  
P.M.C. for said County and State on Acre  
Book 106, page 658, same having the follow-  
ing metes and bounds, to wit:

and running thence N 40° 21' along line  
of Lot No. 22, 346 feet to a stake; thence  
along line of Lot No. 14 S 40° 21' feet to  
center of Lot No. 23, thence S 39° 30' feet
