This deed is executed and delivered by the Board of Governors of Greenville Unit, Shriners' Hospital for Crippled Children, under and by virtue of the authority contained in a resolution unanimously adopted at a meeting of the Trustees of Shriners' Hospital for Crippled Children held in Dallas Texas, on February 26, 1929.

The grantor does also, in consideration of said payment, hereby assign and transfer to Greater Greenville Sewer District Commission all of its right, title and interest in the rights of way obtained by the grantor for the construction, operation and maintenance of said sewer line, with the apparatus in connection therewith, and all rights obtained by the grantor of every nature and kind under said rights of way, the said contracts for rights of way hereinabove referred to being as follows:
