Payne*, all our right, title and interest in and to *None* Township, Greenville County, State of South Carolina.

On the Piedmont Road, near Piedmont S. C., and having the following metes and bounds, according to a plat made by *H. F. Lee*, October 1922, to wit:
Beginning at an iron pin on the Piedmont Road, corner of Piedmont Manufacturing Co. land, and running with its line and *H. Jones*, S. 13 1/2 N. 16. 40 to a stone; thence N. 81 1/4 E. 6. 30 to a stone, *H. F. Neelitt* land, thence with his line S. 44 E. 15. 55 to a stone, *George Thompson* land, thence N. 46 E. 2. 25 to a pin; thence S. 39 E. 2. 25 to a stone; thence S. 48 E. 2. 25 to a stone; thence N. 46 E. 3. 10 to a stone corner of land this day conveyed to *J. C. Payne*; thence with his line S. 73 N. 15 1/2 E. 2. 55 to iron pin on Piedmont Road; thence with said road S. 89. 00 E. 7. 11 to a bend in said road; thence N. 82 1/2 E. 3. 00 to the beginning corner and containing thirty (30) acres, more or less.
