all that piece, parcel or lot of land in Greenmile Township, Greenville County, State of South Carolina.

Known and designated as Lot no 26, and parts of Lots nos 19 and 25 of the Sans Souci Mills subdivision, according to plat recorded in the office for Greenville County in Plat Book A, at page 514, 515 and having the following metes and bounds, to-wit:

Lot no 26, and part of Lot no 19: Beginning at an iron pin on Brockman Avenue, at the northeast corner of lot no 25, thence running N. 57-25-24 179 feet to iron pin on front line of Lots nos 18 and 19; thence N. 31-35-36 84 feet to an iron pin on front line of Lots nos 19 and 20; thence S. 57-25-24 145 feet to an iron pin on Brockman Avenue, corner of Lot no 27; thence with Brockman Avenue S. 10-31-24 91 feet to the beginning corner.

Part of Lot no 25, having the following description: All that certain lot of land situate in Greenville County South Carolina, a short distance without corporate limits of the City of Greenville, known and designated as Sans Souci Mills subdivision, and having the following metes and bounds:

Beginning at a stake on Brockman Avenue, and at the corner of Lot no 26, and running thence N. 57-25-24 145 1/2 feet to corner of Lot no 19; thence with line of Lot no 18 southwest 35 feet to a pin; thence about 150 feet to a point on Brockman Avenue, which corner is 25 feet from corner of Lot no 26; thence with Brockman Avenue N. 10-31-24 25 feet to beginning corner.
