in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said K. G. Morris,

all that piece parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

Containing on south side of Hammond St., at corner of Chicora St. and having the following notes and bounds to wit:

Beginning at a point on corner of said Hammond and Chicora Streets and running thence with Hammond St. 52.25 feet to a stake; thence in a southerly direction with joint line of lots Nos. 40 and 41; one hundred (100) feet to a stake; thence in an easterly direction 51.54 feet to a stake on Chicora Street; thence with Chicora St., in a northerly direction 100 feet to the beginning point as shown on plat of Property of Thomas W. Walker recorded in plat book E, at page 148, said lot being designated as lot No. 40 on said plat.

As a part of the consideration the grantee herein assumes and agrees to pay the unpaid portion of a mortgage the original sum of which was \$3000.00 the unpaid balance of the principal of which is \$3000.00

Said mortgage was executed July 9, 1929, by Lakeside Realty Corp., in favor of Jas. P. Davenport, recorded in Vol. 198, page 83, payable in five equal annual installments of \$600.00 each—the first installment being due July 9, 1929, and annually thereafter in like amount until the full amount is paid.

The first two installments due (July 9, 1929 and July 9, 1930) have been paid.

The grantee herein assumes interest account of said balance of \$3000.00 from date of conveyance herein.

The above described land is the same conveyed to me by Kenesaw Investment Corp., recorded in office of Register of Mesne Conveyance for Greenville County, in Book 72, Page 566 TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said K. G. Morris, his heirs and assigns forever.

heirs and assigns, against me and my heirs, and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.
