Talley his heirs and assigns all of our right title and share in and to all that piece parcel or tract of land in level and Township Greenville County State of South Carolina lying and being situated on the South side of Saluda River the same known as tract no 4 in the division of the real estate of A. B. Talley deceased and hath the following metes and bounds to wit; Beginning on White Hickory and cross pin on Bank of River thence S 70 1/2 E 4 1/2 to cross pin at edge of Bottom thence S 6 E 189 to sweet gum and Spruce pine at Branch thence up said Branch following the meanders thence S 40 E to W. D. X 2 thence N 60 W 11.50 to stone X 2 on W. D. log line thence north said log line N 85 E 20.50 to stone on Bank of River the center of River to be the line thence N 15 E 200 Bend thence N 34 E 150 Bend thence N 60 E 500 to the beginning contains Thirty eight and one half (38 1/2) acres more or less adjoining lands of W.
