all that certain *piece, parcel or lot of land*, in *Greenville* Township, *Greenville* County, State of *South Carolina*, about *two miles* from the city of *Greenville*, on *Summit Drive*.
Beginning at the point corner of *Mahaffey and R. J. Blas* line, and commencing thence in *an eastward* direction along the joint line of *Mahaffey and Blas* three hundred feet to a corner; thence *sixty-eight feet* in a *northward* direction, parallel to the line of *Summit Drive* to a corner; thence *three hundred feet* in a *western* direction, parallel to the said joint *Mahaffey-Blas* line, on *Summit Drive* to a corner; thence *sixty-eight feet* in a *southward* direction along *Summit Drive* *sixty-eight feet* to the corner of beginning.
