All that certain tract or parcel of land situated partly in Updegraff Township and partly in Highland Township, Greenville County, South Carolina, containing fifty-six (56) acres, more or less, containing part of a tract of land granted to Joseph McCool in 1874, situated on Thompson's Beaver Dam Creek and agreeing the following metes and bounds, to-wit:
