All that certain piece, parcel and lot of land lying
and being situate just outside the City of Greenville in
a subdivision known as Alta Vista and designated upon
a plat of said subdivision as lot no 69 and a portion
of lot no. 73, reference being made to the said plat for a
more definite and particular description, the said plat
being recorded in office of R. M. C. for Greenville County
in Plat Book "G" at page 20, and the said lot on that
plat being specifically described as follows:

Beginning at a point on the east side of Oliver street
at the corner of lot no. 68 on said plat and running
thence N. 4° 15' E. 254.5 ft. to the eastern line of lot no. 73 on
said plat; thence along east side of lot no. 73, N. 85° 45'
W. 66 feet to a corner; thence S. 4° 15' W. 254.5 feet to
Oliver street; thence along Oliver street, S. 85° 40' W. 66
feet to the beginning corner, said conveyance covering
all of lot no. 69 and a strip the entire width of lot
no. 73 located directly in the rear of lot no. 69, being
a portion of the property conveyed to me by the South
Carolina National Bank of Charleston, as trustee.
