Lot No. 5: Beginning at a point on Hilltop Avenue 267 feet east of Franklin Road and runs thence S. 46.35 W. 149.1 feet; thence S. 46.55 E. 50 feet; thence N. 46.15 E. 145.6 feet to Hilltop Avenue; thence along said Avenue N. 43.6.50 feet to the beginning corner.
