All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the west side of Elizabeth Street, known and designated as Lot # "M" of North Hill Subdivision on plat of said property recorded in R. M. b. Office for Greenville County in Plat Book A, at page 90, having the following metes and bounds:

Beginning at an iron pin on the west side of Elizabeth Street, which point is 260 feet in a northward direction from the intersection of the west line of Elizabeth Street with the north line of Garrison Street, and running thence along the western line of Elizabeth Street N 11 2' 35 E. 50 feet to an iron pin, thence N 69-13 21-155-2 feet to an iron pin, thence S 12-35-21-4-0 feet to an iron pin, thence S 65-35-21-157-5 feet to an iron pin on Elizabeth Street, the point of beginning, and being the same property conveyed to South Atlantic Investment Corporation by an undated Master Deed August 11, 1931, and to be recorded and surveyed as with.
