TITLE TO REAL ESTATE

in the City of Greenville beginning at a point in center of old run of Reddy River and on line of a fifty foot continuation of Bailey Street, running thence up said run fifty feet seven inches to a point thence N 30 E four hundred ninety-two feet to Green Street, thence along Green Street 64-15 East fifty feet three inches to a point, thence S 30 W four hundred eighty-one feet to beginning point. The above strip of land is given for the purpose of continuing Bailey Street across the Mayberry McAdon to Green Street and if said strip should at any time not be used for said purpose then it shall revert to me, my heirs and assigns.
