all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,

known as part of lot No. 6 on plat by F. G. Rogers, recorded February 1912, on the Easley Bridge Road, about three miles from the City of Greenville, described as follows:

Beginning on the Easley Bridge Road, corner of lot this day conveyed to C. M. Pennington and running thence with his line S. 50 W. 150 feet to Pennington's line; thence with his line S. 54 1/2 N. 55 feet to stake; thence N. 50 E. 150 feet to stake on Easley Bridge Road; thence along said road N. 54 1/2 E. 55 feet to the beginning.
