Beginning at a point in the middle of said Paris Mountain Road, running thence S.  
58.32 W. 1163.5 feet to an iron pin, lands of American Spinning Company; thence with line  
of lands of said company, N. 58.00 W. 357 feet to an iron pin; thence N. 53.38 E. 1318.5  
feet to a point in Paris Mountain Road; thence with line along the middle of said road,
