

TITLE TO REAL ESTATE

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A. B. Reid, all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,

about three and one-half miles west of Greenville Court House, containing eight acres, more or less, and described as follows: Beginning at an iron pin on south side of Dunham Bridge Road (New Cut), corner of R. J. Rowley, and running thence with his line S. 55-55 E. 709 feet to stone; thence continuing with same line N. 74-85 E. 459.7 feet crossing a branch to an iron pipe, corner of W. P. Lark; thence with his line N. 2 W. 138.2 feet to iron pin on east bank of branch; thence N. 74-04 W. 623 feet to iron pin; thence N. 15-36 E. 100 feet; thence N. 38-49 S. 108 feet, more or less, to iron pin; thence N. 74-04 W. 440 feet to iron pin on Dunham Bridge Road; thence with said road S. 15-36 W. 345 feet to beginning; being the two tracts conveyed by Julia D. Charles as Trustee for J. R. Yow to F. W. Haynie by deed recorded in Book 151, page 128 and Book 151 page 172, and the same conveyed by F. W. Haynie to Julia D.
